



**2010 Spring Dogwood Championship**  
**Montgomery Bell State Park, Burns, Tenn.**

**Official TGA Sanctioned Point Event**

\***Format:** A 36 Hole designated event for amateurs, individual stroke play with a Championship Division and a Senior Division. Seniors play separate tees and must declare which division they will participate in. Senior division entrants must be 55 years of age by April 17<sup>th</sup>, 2010. Once declared seniors do not compete against the Championship Division.

\***Eligibility:** Amateurs who meet the USGA definition of an amateur golfer. Amateur participants, including senior amateurs must possess a valid TGA/GHIN Handicap Index. All amateur entries will be verified upon receipt and any amateurs not listed on the April 1<sup>st</sup> revision date of the TGA/GHIN Handicap index will not be eligible.

\***Senior Division:** Age for senior division 55 and older.

\***Entry Fee:** \$150.00 Per player, (includes carts, green fees/range fees) awards, and prizes.

**Make checks payable to (Treasurer State of TN MBSP Golf.)**

\***Practice round:** Friday April 16th. Entry Fee covers green fees, cost of carts are not included in practice round.

\***Entry Deadline:** Wednesday April 7th, 2010 at 5:00 p.m. (CST). Late or incomplete applications not accepted.
